#### Conference Room D *Debts, Deficits, and Defense*

Handwriting over the federal deficit. Exhortations from Congress for deep budget cuts. Recommended Defense Department cuts mysteriously reinstated and the Pentagon budget ever rising. With such incoherent puzzle pieces, it is difficult to assess how to capitalize on the demand for deficit reduction to achieve meaningful reductions in military spending – representing half of all discretionary spending – and a better balance with non-military means of promoting peace. This session will help participants understand the historical context of the current budget, while exploring the perspectives of new stakeholders in the national dialogue to reprioritize the budget and opportunities to enact systemic reform.

#### *Surveillance and Profiling: Protecting Human Rights While Confronting “Violent Extremism”*

This session comes on the heels of Representative Peter King’s controversial Homeland Security Committee hearing, "The Extent of Radicalization in the American Muslim Community and That Community’s Response," and increased anti-Muslim rhetoric. At the same time, Congress seems increasingly ready to take up legislation that could further tilt the balance between surveillance and privacy. This session will examine federal policy efforts, opportunities, and challenges in the areas of ethnic and religious profiling, intelligence collection, law enforcement, and privacy, and discuss strategies for advancing reforms.

### ***Detention and Treatment of Terrorism Suspects: Securing Human Rights and Accountability***

In January 2009, President Obama issued groundbreaking executive orders to end torture, shut down CIA secret prisons, and mandate the closure of the Guantanamo Bay detention center within one year. Two years later, Guantanamo remains open, Congress has passed legislation obstructing efforts to close the facility, and proposals are pending to make preventive detention permanent for many detainees. Issues regarding detainees in Afghanistan and ensuring U.S. accountability also endure. This panel will examine the current federal policy efforts, opportunities, and challenges around these issues and suggest what role funders can play in advancing a human rights agenda in the context of an ongoing struggle against terrorism.

### ***The Politics of Withdrawal: The Challenges of Peacebuilding and U.S. Military Action in Afghanistan***

U.S. military leaders have presented positive military metrics to defend their assertion that America's longest war is now going well, recognizing that the political process in Afghanistan is the central challenge and priority. But unabated violence, lack of notable progress in political and economic development, and the strength of the Taliban present a precarious picture. Although a majority in the United States wants the troops to leave, the Obama Administration announced that the promised withdrawal this July will amount to a "thinning out" of support troops. This session will probe the status of political negotiations, the military campaign, and rebuilding/peacebuilding efforts in Afghanistan. Discussion will also explore how funders can constructively engage the policy-making process and support peacebuilding efforts.

Since mid-January, the Middle East has experienced an unprecedented wave of popular uprisings that has quickly swept from power the autocratic rulers in Tunisia and Egypt, led to a rebellion and violent government crackdown in Libya, and threatened several other repressive regimes elsewhere in the region. The Arab publics' struggle for dignity, freedom, and more transparent and responsive governments – a long term struggle to be sure – has challenged the United States as it seeks to chart a policy course that is both respectful of core values of human rights and democracy, and mindful of its broader strategic interests in the region. Panelists will assess these historic and quickly evolving events, the prospects for democratic reform in the Middle East, and the dilemmas for policymakers as they respond to the political tumult currently engulfing the region.

### 10:45 am-12:00 pm ***Outsourcing, Revolving Doors, No-Bid Contracts, and No-See Oversight: The Failure of Government Accountability in National Security Policymaking***

Private contractors now perform many services traditionally handled by government and national military forces, including key intelligence services, war-zone security, international communications surveillance, even covert operations. This heavy reliance on contractors is leading to a fusion of private and state interests, seriously threatening oversight and accountability of actions taken in the name of our government. Privatization advocates claim that outsourcing is economically efficient; detractors argue that private contractors are profiting at the expense of our diplomatic, and even military, mission and are fueling a permanent war economy. This session will examine the nature of government outsourcing and assess its impact on our economy and implications for an open and accountable government. Our discussion will also explore the critical role of foundations, non-profit watchdogs and policy-makers in this effort.
